1. Call to Order – Chairman *Meeting called to order at 4:12 PM.*
2. Roll Call – Ryan Hackmann *Board Members Present: Rick Ogston, Joe Asen, Chet Crain. Board Members not present: none School staff present: Ryan Hackmann Others present: none*
3. FY24 Meeting Schedule – Ryan Hackmann *Ryan explained that as we did not have Joe's input on a schedule yet, we would establish the schedule after the meeting. No vote was taken.*
4. Financial & Enrollment Update – Ryan Hackmann *Ryan updated the board on enrollment figures as of Thursday, September 14, 2023. He also briefly discussed the highlights of the financial statements for full fiscal year of 2023. He then opened the floor for questions and comments. Chet Crain made a motion to approve the financial statements as presented. Joe Asen seconded the motion. Rick Ogston, Chet Crain, and Joe Asen voted in favor of the motion. There were none opposed. The motion passed 3-0.*
5. Operational Update – Ryan Hackmann *Ryan noted that the schools were beginning the implementation of Raptor security software. Joe Asen mentioned that several schools he has worked with use Raptor and that it is good software. Ryan let the board know that the school was in a 5-year interval monitoring year and that ASBCS would be visiting and doing a review this year. Ryan also updated the board on the audit, letting them know that the auditor had indicated a good audit thus far and she expected to finish the process within a week or so.*
6. Administrative Update – Rick Ogston *Rick said he had nothing to cover for the administrative update.*
7. Adjourn – Chairman *Rick Ogston made a motion to adjourn. Chet Crain seconded the motion. Rick Ogston, Chet Crain, and Joe Asen voted in favor of the motion. There were none opposed. The motion passed 3-0. The meeting was adjourned at 4:34 PM.*
