1. Call to Order – Chairman *Meeting called to order at 4:02 PM.*
2. Roll Call – Ryan Hackmann *Board Members Present: Rick Ogston, Chet Crain, Joe Asen. Board Members not present: none School staff present: Ryan Hackmann Others present: none*
3. Rural Arizona Group Health Trust Resolution for Approval for the Amendments to the Declaration of Trust – Ryan Hackmann *Ryan informed the board that the resolution was required in order for the trust to remove the physical address from the trust agreement and that the site was no longer actually the correct location for the trust office. Joe Asen made a motion to approve resolution as written. Chet Crain seconded the motion and authorized Ryan to use his stamp to sign the director section. Rick Ogston, Chet Crain, and Joe Asen voted in favor of the motion. There were none opposed. The motion passed 3-0.*
4. FY2025 Proposed Budget – Ryan Hackmann *Ryan explained the preliminary nature of the budget and highlighted some major differences, including adding a special education teacher, and free lunch for all students. Joe Asen asked about the types of students served in the school's special education department and Ryan gave a general description of the classifications of students the school serves. Chet Crain made a motion to accept the budget as presented. Joe Asen seconded the motion. Rick Ogston, Chet Crain, and Joe Asen voted in favor of the motion. There were none opposed. The motion passed 3-0.*
5. Adjourn – Chairman *Chet Crain made a motion to adjourn. Joe Asen seconded the motion. Rick Ogston, Chet Crain, and Joe Asen voted in favor of the motion. There were none opposed. The motion passed 3-0. The meeting was adjourned at 4:18 PM.*
